MEETING MINUTES / SEPTEMBER 19, 2023 / 10:30 AM

1. CALL TO ORDER

Chair Joseph called the meeting to order at 10:31 AM.

2. <u>INTRODUCTIONS</u>

No introductions were made.

3. CHANGES TO THE AGENDA

There were no changes to the agenda.

4. APPROVAL OF THE AUGUST 15, 2023 MEETING MINUTES*

Anton Schauerte indicated that Ali Townsend should be added to the participant list. A motion was made by Steve Stepek, supported by Ryan Buck, to approve the August 15, 2023 meeting minutes with the aforementioned changes. The motion passed unanimously.

5. TREASURER'S REPORT

Lindsay Wallace indicated that included in the packet is a report showing the amount of money spent at the 2023 MTPA Conference. The current balance is \$19,500.

6. EDUCATION COMMITTEE

Chair Joseph requested the Education Committee organize a training between the MPOs and MDOT's OPT to discuss each group's operating processes and procedures.

7. FHWA / FTA UPDATE

Jenny Staroska stated there is a new public right-of-way accessibility rule and there is an upcoming webinar regarding the topic. Jenny also requested MTPA make any future in-person meetings hybrid in order to ensure MTPA meetings remain accessible to the public. Chair Joseph encouraged participants to attend the October MTPA meeting in-person. Andrew Sibold announced FHWA released the NOFO for the Electric Vehicle Charger Reliability and Accessibility Accelerator grant, which is part of the NEVI program (Applications due 11/13/23).

Kathleen Russell explained that FTA is hosting a real estate webinar, which will take place on October 3rd.

8. TAMC UPDATE

Ryan Buck mentioned that the Fall Asset Management Conference will take place in Grand Rapids. There is discussion about using a "work project" to extend FY23 funds to FY24 for a project. The FY25 budget is being developed now and more information will be known after the conference.

9. FINANCE COMMITTEE

Chair Joseph requested that if committee members have topics worth discussing to please let her know.

10. POLICY COMMITTEE

Steve Stepek stated that the committee met to discuss the draft MOU. There have been some modifications and a new draft will be sent out shortly.

11. JOBNET TECH

Jeff Franklin stated that the committee met on September 11th. The two main production updates include the migration from Version 22 to Version 23 for the map data and the EJ function will go live shortly. There will be a JobNet 101 training course in the future. Additionally, the Air Quality Conformity Task Force will design an Air Quality Report and also a specific page in JobNet to feature the topic. Jeff stated that Luke Walters will take over the JobNet Tech committee meetings in the future.

12. MDOT UPDATES

<u>SPS General Update:</u> Don Mayle stated that there are no other updates other than the remaining MDOT agenda items and passed it along to John Lanum to discuss TPM updates.

<u>TPM Update:</u> John Lanum stated the new data for the 2-year and 4-year pavement and bridge condition, and reliability targets, should be published on MPOs websites. MDOT established the CY 2024 Safety targets and the official letters are forthcoming. Don Mayle indicated that the updated draft MOU will be processed internally by MDOT before the final version is sent to the MPOs.

<u>Financial Update:</u> Matt Lyle stated MDOT received August Redistribution; the state gained about ~\$234 Million of obligation authority. Of this, the trunkline program received \$175 Million and \$58 Million for the local program. There may be a low obligation authority in FY25, then higher August Redistribution at the end of the FY. The FY24 apportionments

should be ready in the next month or two. Additionally, regarding the drunk driving penalty, FHWA confirmed that suballocations will not be impacted for ST funds, only the Flex funds. Funding changes to MPO's FY24, FY25, and FY26 allocations, as a result o the 2020 U.S. Census, will be published in October. MPOs will be provided time afterwards, however, to amend projects in the FY 2023-2026 TIP to ensure MPOs remain in fiscal constraint.

MTP 101 Training Session #3/5: Brad Sharlow reminded the Committee that later in the afternoon is the third MTP 101 training. Brad also inquired about how MTPA can access large files that are too large to send via email or publish on the MTPA website. There was a discussion to place large files on Zoom, the MTPA Google Drive folder, or the same service MDOT uses to publish its RTF meetings.

13. OTHER NEW BUSINESS

Chair Joseph stated that the next MTPA meeting will be a hybrid meeting, with the in-person component being at the Earle Learning Center (7575 Crowner Dr., Dimondale, MI). Don Mayle indicated that the designation package for the Traverse City MPO has been recently submitted. Brad Sharlow asked whether the MTP 101 Training #4 sessions should be in-person, online, or hybrid. There was interest in having the training be hybrid.

14. ADJOURNMENT

Chair Joseph adjourned the meeting at 11:14 AM.

Updates from FHWA to MTPA October 17, 2023

Grants - Key NOFO List

Fiscal Year 2024 Appropriations Approved Through November 17, 2023

The President signed a <u>continuing resolution</u> on September 30, 2023 to approve Federal funding programs for Fiscal Year (FY) 2024 through November 17, 2023.

FHWA Announces \$9.6 Billion in Available Funding for the Bridge Investment Program

On September 27, 2023, the Federal Highway Administration (FHWA) published a <u>Notice of Funding</u> <u>Opportunity (NOFO)</u> to announce the availability of up to \$9.62 billion in funding for Large Bridge Project Grants through the <u>Bridge Investment Program</u>. Grants are available for bridges with total eligible project costs over \$100 million, with minimum grant awards of \$50 million, and maximum grant awards of 50 percent of the total eligible project costs. Here are the application deadlines:

- November 27, 2023, for consideration of funding from FY 2023 and FY 2024;
- August 1, 2024, for consideration of funding from FY 2025; and
- August 1, 2025, for consideration of funding from FY 2026.

FHWA Announces \$100 Million in Available Funding for Electric Vehicle Charging Infrastructure

On September 13, 2023, FHWA <u>announced</u> the availability of \$100 million in funding through the Electric Vehicle Charger Reliability and Accessibility Accelerator Program to repair and replace existing, but non-operational, electric vehicle charging infrastructure. Eligible applicants for this program are limited to State Departments of Transportation (DOTs) and local governments. The application deadline is November 13, 2023. USDOT Announces Technical Assistance Opportunities for the Thriving Communities **Program**

On September 12, 2023, the U.S. Department of Transportation (USDOT) <u>announced</u> that the <u>Thriving Communities Program</u> is now accepting applications for FY 2023. Applicants interested in receiving technical assistance and peer learning support, have until November 15, 2023 to submit a Letter of Interest. Applicants interested in providing technical assistance, planning, and capacity building support, have until November 28, 2023 to submit an application. EPA Starts 2-Year Conformity Grace Period for New MOVES4 Emissions Model

On September 12, 2023, the Environmental Protection Agency (EPA) published a <u>notice</u> in the Federal Register to announce the availability of the latest Motor Vehicle Emission Simulator model major release (MOVES4) for official purposes outside of California. MOVES4 is the latest version of the EPA's state-of-the science modeling tool for estimating emissions from cars, trucks, buses, and motorcycles based on the latest data and regulations. This notice starts a two-year grace period (i.e., September 12, 2025) before MOVES4 will need to be used as the latest EPA emissions model for transportation conformity determinations outside of California, both in new regional emissions analyses and in new hot-spot analyses. Census Bureau Publishes Technical Corrections for a Subset of Urban Areas from the 2020 Census

On September 12, 2023, the Census Bureau published a <u>notice</u> in the Federal Register to make technical corrections to their previous <u>notice</u> published on December 29, 2022. For a small number of urban areas in California, Georgia, and Louisiana, the Census Bureau updated the population totals, housing counts, and land areas. FHWA and FTA will use these technical corrections to update the Transportation Management Area (TMA) designations published in the <u>Federal Register</u> on June 5, 2023. Stay tuned for more information.

FHWA Seeking Public Comments on Intention to Collect Information from States and MPOs

On August 31, 2023, the FHWA Office of Planning, Environment, and Realty published a <u>notice</u> in the Federal Register to request public comments on the agency's intention to collect information from State DOTs and Metropolitan Planning Organizations (MPOs) regarding planning and research work programs, periodic progress reports, and periodic financial reports, as part of <u>23 CFR Part 420</u> and <u>2 CFR Part 200</u>. On September 6, 2023, FHWA published a <u>notice</u> in the Federal Register to extend the public comment period until November 6, 2023. FHWA will summarize and/or include public comments in its information collection approval request to the Office of Management and Budget (OMB).

FTA Publishes Research on Practical Measures for Advancing Public Transit Equity and Access

In July 2023, the Federal Transit Administration (FTA) published a research <u>report</u> entitled, "Practical Measures for Advancing Public Transit Equity and Access." The report identifies a set of replicable measures that public transportation providers and their partners can use to advance equity for those who have been historically underserved, marginalized, and adversely affected by persistent poverty and/or inequality. These include practical strategies such as advisory committees and intergovernmental

partnerships as well as analytical techniques that quantify how public transit links people to opportunities.

Freight Analysis Framework

Federal Highway Administration (FHWA) published two visualization tools utilizing data from the Freight Analysis Framework (FAF5.5.1) and historical Vehicle Inventory and Use Survey (VIUS) data. The new public tools will simplify access to these large data sets and make it easier to analyze complex freight flow patterns at national, State and local levels. FAF and VIUS data are used in many States' freight plans to support analysis. These tools can also be useful for identifying needs and key issues confronting the freight system, planning and prioritizing projects, and improving an applicant's analysis and justification for federal discretionary grant funding.

<u>FAF Data Visualization tool</u>- allows users to rapidly create customized freight dashboards that can be downloaded for further distribution. The tool provides information about the amount and type of goods moved by various modes of transportation between large metropolitan areas, States, and regions for years 2017-2022, including forecasts for three different freight demand scenarios through 2050.

<u>VIUS Data Visualization tool</u>—includes information on the physical and operational characteristics of the U.S. truck population. Currently, VIUS visualization tool includes historical VIUS data for years 2002, 1997 and 1992. The VIUS visualization tool will be updated in the coming months with the newly released <u>VIUS2021 data</u>. The tool allows to rapidly create customize freight summaries that can be downloaded for further distribution.

NCHRP Publishes Research on Rural Access, Freight Integration, Life-Cycle Planning, and Probe Data

October 2023 Updates from FTA to MTPA

FTA Issues Advisory to Improve Safety for Pedestrians and Cyclists Around Buses

FTA issued a <u>safety advisory</u> to recommend that transit agencies take action to reduce bus-to-person collisions, which remain a top safety concern. Between 2008 and 2021, bus-to-person collisions accounted for 15 percent of all transit fatalities.

FTA has also posted a <u>Bus-to-Person Collision webpage</u> with information about the advisory and available data.

FTA Issues Dear Colleague Letter highlighting FTA Grant Programs to Support Real-time ADA Paratransit Service

To promote equity in public transportation, FTA has issued a <u>Dear Colleague Letter</u> to highlight FTA grant programs that can be used to provide paratransit service to eligible riders on a real-time basis and/or allow for intermediate stops.

While next-day, advanced reservation service is the minimum requirement under the Americans with Disabilities Act (ADA) regulations for ADA complementary paratransit, FTA grant recipients have the option to provide more flexible paratransit service based on community needs. As the letter explains, funding through Urbanized Area Formula Grants (Section 5307), Enhanced Mobility of Seniors and Individuals with Disabilities (Section 5310), Formula Grants for Rural Areas (Section 5311), and Buses and Bus Facilities (Section 5339) programs can be used to support local decisions to provide real-time paratransit and/or allow for intermediate stops.

FTA/FHWA Virtual Peer Exchanges on Asset Management and Planning; Oct 23-24 and Nov 1-2

FTA and FHWA will host a series of joint virtual peer exchanges focused on **integrating asset management into planning and programming** in October and November 2023. These peer exchanges will provide an opportunity for State DOTs, MPOs, and transit agencies to discuss challenges, opportunities, and benefits of incorporating asset management in their planning and programming practices with peer agencies.

FTA Seeks Public Input on the Draft Greenhouse Gas Emissions from Transit Projects: Programmatic Assessment

FTA is seeking public input on the <u>Draft Greenhouse Gas Emissions from Transit Projects: Programmatic</u> Assessment.

The Programmatic Assessment is a streamlining tool that analyzes estimated greenhouse gas (GHG) emissions generated from the construction, operations, and maintenance phases of transit projects. The findings provide a reference for FTA and its project sponsors to use in environmental documents to describe the effects of proposed transit investments on partial lifecycle GHG emissions.

FTA has published a notice summarizing the Draft Programmatic Assessment in the <u>Federal Register</u>. FTA encourages stakeholders to review the notice and provide comments through November 24, 2023.

NOW AVAILABLE: Spotlight on Safety: Transit Rail Grade Crossings Webinar Recording and Presentation

FTA hosted a webinar on Thursday, September 21, 2023 to discuss transit rail grade crossing safety from both the operational and public education and outreach perspectives. A <u>recording</u> of the webinar and the <u>presentation</u> are now available.

FTA provided an overview and the Center for Urban Transportation Research and MxV Rail highlighted research on engineering aspects related to rail grade crossing safety, as featured in the FTA Standards Development Program *Rail Transit Roadway and Pedestrian Grade Crossings Exploratory Report*, and discussed trespassing research results. The webinar also featured guest speakers from TriMet who talked about their experiences with rail grade crossings and the non-profit, Operation Lifesaver Inc., who discussed safety education and outreach to transit riders and available transit agency resources.

Centers for Medicare & Medicaid Services Releases New Medicaid Transportation Coverage Guide

Medicaid provides health coverage to millions of Americans, including eligible low-income adults, children, pregnant women, older adults, and people with disabilities.

Non-emergency medical transportation (NEMT) is an important Medicaid benefit for beneficiaries who need assistance getting to and from medical appointments. Medicaid is one of the 130 Federal programs

found in the <u>Coordinating Council on Access and Mobility Program Inventory</u>; and the largest funder of NEMT, with an estimated FY 2018 spending on transportation of \$1.4 billion.

Today, the Centers for Medicare and Medicaid Services (CMS) released a <u>State Medicaid Director Letter</u> which introduces the Medicaid Transportation Coverage Guide ("Guide"). This CMS guidance serves as a consolidated and comprehensive compilation of Medicaid transportation policy, providing a one-stop transportation resource for states on federal requirements and state flexibilities.

The Guide largely highlights existing policies but also includes new policies to address scenarios for extended wait times and long-distance trips. The Guide also encourages partnerships, "Public transit agencies are often utilized in state Medicaid transportation programs and recognized as one of the least costly options. State departments of transportation (DOTs) and Medicaid agencies should explore partnerships to better serve the Medicaid population." To learn more, view the Medicaid Transportation Coverage Guide.

Transit Workforce Center to Expand Collaboration and Support to Address Labor Shortage

In the two years since FTA established the <u>Transit Workforce Center (TWC)</u> as a national technical assistance center for workforce development, it has made significant strides in working with transit agencies to recruit, hire, train and retain a diverse workforce. To support transit agencies and help them engage and retain employees, the TWC provides case studies and examples of ways transit agencies and industry stakeholders address worker safety and health, skills development and developing accurate workforce metrics. It has provided a range of resources, including:

An extensive Resource Center with a range of reports, webinars, best practices, and case studies;

A National Frontline Transit Worker Recruitment Toolkit;

Zero Emission bus resources;

Apprenticeship and mentoring initiatives;

A Transit Data Dashboard;

An e-newsletter, The Pulse, and the TWC blog, featuring career stories and other successes.

To date, TWC resources and trainings have reached over 7,000 industry professionals and 400 transit agencies.

The TWC was recently highlighted in a <u>video message</u> by FTA Deputy Administrator Veronica Vanterpool, who applauded the TWC's accomplishments at its second anniversary. In the months ahead, TWC activities will be guided by <u>FTA's National Transit Workforce Development Strategic Plan</u>, which outlines the areas of workforce support and focus through 2028.

In its next phase, TWC plans to:

Continue providing technical assistance to public transit agencies;

Collaborate with the Departments of Labor and Education to expand career pathways for K-12;

Strengthen and expand health and safety initiatives, training, funding, and support;

Measure the impacts of diversity, equity, inclusion, accessibility, and belonging initiatives; and

Help transit workers adapt from traditional technologies to emerging technologies.

<u>The plan</u> reinforces the Biden-Harris Administration's labor investment and recognizes the need to prioritize worker health and safety post-COVID-19.

The Fiscal Year 2024 funds will support efforts to replace our nation's aging railcars for the safety and convenience of riders everywhere.

The <u>Rail Vehicle Replacement Program</u> will fund transit agencies and state and local governmental authorities' efforts to replace rail vehicles that are approaching or have exceeded their useful life, so that passengers will experience an improved commute.

Complete proposals must be submitted electronically through the *GRANTS.GOV* "APPLY" function by 11:59 p.m. Eastern time, Monday, December 18, 2023.
